<u>PUBLIC COMMENTS</u>: Mr. Brennon Breaux introduced himself and discussed SLEMCO's services.

MINUTES: The minutes of the July 21, 2023, meeting were approved as written on a motion made by Ms. Nikki Vidos. Mr. Elliot Broussard duly seconded the motion, and it was unanimously carried by the board.

Ms. Kristy Doucet-Touchet entered the meeting.

TREASURER'S REPORT: Mr. Ruben Rivera gave the Treasurer's Report. The board was provided with a list of invoices and expenses totaling \$622.85. Ms. Nikki Vidos gave the report for the Transition Committee. She informed the board that VEDD has received 5 applications for the Economic Development Liaison position. She noted that interviews will be scheduled in the coming week.

Ms. Vidos updated the board on requests from the business community that the Transition Committee has managed in the past month. She noted that they received one request for a grant support letter, which was submitted, and a new industry inquiry that VEDD will be looking into.

Ms. Vidos gave an updated from the Sustainable Funding Committee. She informed the board that Mr. Rivera gave an update to the Vermilion Parish Police Jury's General Needs Committee and presented the new proposition language as well. The committee voted unanimously to approve VEDD's

proposition being placed on the March 23, 2023, ballot and it will go before the Police Jury at their regular meeting on August 16, 2023, for ratification.

Ms. Vidos gave an update on the Strategic Planning Committee. She noted that there have not been enough responses to the LDRC survey to be able collect the needed data. She asked the board for assistance in getting the survey out to the public.

There was no update from the Communications and Promotions Committee.
